MEET CONDUCT:

EVENT CHECK – IN:

Running event participants must check-in with the meet clerk, no later than 15 minutes prior to the start of the scheduled event. If contesting the finals of the 100 meters or 100/100MH, you must declare intent to compete in the final 30 minutes prior to the start.

WARM – UP AREAS

Warm-ups for running events must be conducted on the middle of the turf field and on the back stretch during the straight-away races.
